

Vocational Education and Training (VET)

STUDENT AGREEMENT

This Agreement sets out your obligations as an enrolled student to Avondale University (Avondale) and Avondale's obligations to you while you are undertaking your studies. By accepting this agreement you are acknowledging that you have read and you understand it. Please also refer to Avondale's student policies and procedures published on the website (<u>Avondale Policies » About Us » Avondale</u>) under VET Student Policies.

As a student enrolled into an Avondale course, I understand that:

- I need to answer all required questions in the application form and supply any required supporting documentation to ensure that my application can be assessed and processed;
- The provision of incorrect information or the withholding of relevant information relating to my application and/or academic transcripts may result in the withdrawal of an offer of a place in my chosen course;
- I may be asked to undertake a language, literacy and numeracy test to enable Avondale to provide the necessary support I may need while I complete my studies and to ensure that I am enrolling into the right level of studies for me to be successful in completing my course.
- I acknowledge that Avondale reserves the right to seek from other bodies verification of any qualification/s, certificates, or other documents that are submitted as supporting documents;
- I have read and understood the fees and financial policies as per the website
 (www.avondale.edu.au/policies/). I am over the age of 18 and understand that I am fully
 responsible for my education tuition fees and living expenses while studying at Avondale.
- It is my responsibility, where applicable, to check myHELPbalance which identifies my available borrowing balance under the combined Higher Education Loan Program (HELP) which includes VET Student Loans.
- Avondale is collecting the information in this application for the purpose of determining my eligibility for entry into my chosen course of study.
- I will receive official Academic and Financial information from Avondale electronically by email including letters, Commonwealth Assistance Notices and invoices and agree to access the correspondence on the email address I have provided in this application
- I agree to keep my personal contact details current.
- Avondale may disclose my personal information (including information about my enrolment) to Australian Government agencies, including Services Australia, where this is required or authorised by Australian law. Personal information disclosed to Services Australia is protected by law, including the Privacy Act1988.
- I am required to notify Services Australia of any change in circumstances that may affect any payments I receive from them.



- I must complete your course before the expiry date outlined in Avondale's confirmation of my enrolment (Maximum Duration). Subject to the Australian Consumer Law, if I do not complete the course within the Maximum Duration, my enrolment will expire, and I will not be entitled to any refund or partial refund of Course Fees.
- If I require additional time to complete the course/units additional costs may be incurred;
- Avondale is a faith-based education provider and I acknowledge the Christian values and standards promoted by the Seventh-day Adventist Church.
- All Avondale campuses are drug and alcohol free. The use of substances including, illicit drugs, alcohol and tobacco is prohibited on any Avondale campus.
- As a student studying at Avondale, I agree to uphold the ideals, standards, and principles set out
