This is what we require:

- I No retouching of any kind (including removal of background, moles, wrinkles or scars)
- I Clear, focused image with no marks or 'red eye'
- I Plain white or light grey background that contrasts with your face
- I Uniform lighting (no shadows or reflections), with appropriate brightness and contrast to show natural skin tone
- I Face centred and looking at the camera straight on; not tilted in any direction
- I Hair off your face, so that the edges of your face are visible
- I Eyes open, mouth closed
- I Neutral expression (not smiling, laughing or frowning)

Photos have to be 35mm to 40mm wide and 45mm to 50mm high. The size of the face from chin to crown can be up to a maximum of 36mm, with a minimum of 32mm.

If you usually cover your head for religious reasons, and if you wear the covering when you cross international borders, then you can wear the covering in your passport photo.

Religious head coverings have to be plain-coloured, not be patterned, and be worn in a way that shows your face from the bottom of the chin to the top of the forehead. The edges of your face on either side also have to be visible.

Avondale University College is required to assess applicants for admission against the Genuine Temporary Entrant (GTE) criteria as defined by the Department of Home Affairs (DHA).

The GTE requirement explicitly addresses whether the individual circumstances of an applicant indicate that their intention is for a temporary stay in Australia. A genuine student is a student who intends to obtain a successful educational outcome and has the language, education and material background to have a reasonable chance of achieving this education outcome.

Factors that are considered under the existing requirement to be a genuine applicant for entry and study as a student include: English language proficiency; financial capacity; prerequisite schooling; age requirements; and intention to comply with visa conditions.
